Troll Solution

Two workers on board the jack-up rig *Troll Solution* were killed on Tuesday (5 May 2015) when the platform suffered a failure of one of its legs resulting in a partial collapse of the structure. The platform, which is located in the Campeche Sound in the Gulf of Mexico, is under contract to the state oil company Petroleos Mexicanos (Pemex). The two workers who were killed were employed by the rig owners Typhoon Offshore which is a subsidiary of Mexico's Grupo Salinas. They have advised that the *Troll Solution* was operated by Harren & Partner with whom Typhoon has an association.

The *Troll Solution* which is under contract to operate in Pemex's Abkatun-Pol-Chuc shallow water oil field, was positioning itself to carry out maintenance on wells linked to the Caan Alf platform in the Campeche Sound when the failure of the leg occurred. A well as the two reported deaths, a further 10 employees were injured in the incident. The platform was staffed by over 100 workers and they



were quickly evacuated into emergency boats which responded to the incident. By mid-afternoon the rig was partially submerged and listing heavily. Oil deposits were also noted in the water but this is thought to be from the diesel on board the rig. A spokesman advised that there had been no spill and refused to confirm the speculation that the rig had sunk.

The Mexican energy sector has been under a state monopoly for nearly 80 years. Mexico is opening up its oil and gas sector to private investment and Typhoon Offshore was set up to take advantage these growing opportunities. The *Troll Solution* rig is Typhoon Offshore's only asset having been purchased during 2014 and has been in operation since then. This is the second incident to hit Pemex in just over a month and concerns are being raised as to safety in the offshore sector.
