Skarven

Date of Casualty 12 April 2019

Type of Casualty Grounding

Type of Claim Hull damage, possible salvage claim and passenger claims

At 0740 hours local time on 12 April 2019 the passenger ro-ro Skarven ran aground in Ekholms Sound in the Gulf of Bothnia, Finland prompting an evacuation of her passengers.

The 2009 built ro-ro ferry was proceeding from Mariehamn and bound for Degerby. Finland when she struck rocks in the narrow Ekholms Sound causing her hull to be holed and oil to leak into the water. She had 25 passengers and six crew on board and was also carrying 19 cars as well as trucks and trailers. The Finnish Coast Guard was notified of the grounding and dispatched craft to assess

the situation. Attending were the SAR vessel Svante G, the tug Subsea VI and the Rescue Bioerkskaer. Passengers were subsequently transferred to attending vessel and transferred to the shore where taxis were on hand to take the passengers to Mariehamn or Degerby.

A large sheen of oil was photographed off the Skarven's port side. After a preliminary dive survey, the vessel was refloated at noon and she proceeded under her own power to the port of Svinö, arriving in the early evening where passengers were permitted to collect their vehicles from the vessel. A more detailed diving inspection confirmed the vessel had suffered a number of breaches in tanks along her port side three metres below the water line and which were across several metres. She entered the Ov Western Shipyard Ltd in Teijo on 14 April 2019.

The Traffic Safety Agency Trafi has commenced an investigation into the accident.



- editions 294, 295, 296, 297, 298, 299, 302, 303, 304, 307, 308, 309, 310, 314 & 315 - after weeks of being on the floating barge Boabarge 33, the frigate has been patched and sealed sufficiently to enable her to be pulled into the Navy's dry-dock at Haakonsvern. Work on mapping the full extent of damage will

Natalia - editions 300, 301 & 302 & 305 - A wreck removal for the removal of the general cargo vessel which ran aground off Karaburun, Turkey on 19 December 2018 loaded with a cargo of soda, has been submitted to the Harbour Master for consideration. If approved the work is

expected to commence in early May. Fuel and lubricants have already been removed.

Yantian Express - editions 302, 303, 304, 305, 306, 307 & 315 - Hapag Lloyd have finally confirmed that the containership is safe to continue with her voyage. Containers offloaded at Freeport and found to be sound are in the process of being reloaded onto the vessel. She is expected to depart from Freeport at the end of April/early May. Property interests have been notified that if they do not provide security urgently their cargo may be subject to a salvage sale by the salvors.

Grande America - editions 311, 312 & 313 - underwater surveys of the vessel, which sits at a depth of 4,000 metres off the coast of La Rochelle, France, continue using the ROV from the Norwegian offshore ship Island Pride. The vessel is resting upright on sand with part of its aft section buried by several metres. Aerial surveillance continues and whilst there have been no more significant spills low intensity iridescence on the water surface above the wreck have been noted.

Sir John Franklin - edition 313 - is undergoing sea trials after completion of the repairs to damage caused when the vessel struck the Victoria breakwater on 22 March 2019. The vessel has had a new propeller, rudder, rudder post and metalwork on its aft port side. The trials are expected to be completed by 26 April 2019

Tango Sol - edition 315 - departed Hartlepool on 10 April 2019 bound for Varna after repairs were completed to stabilise the vessel and the Maritime and Coastquard Agency lifted their detention notice.
